Dear Sir/Madam,

This is to inform your good office that for giving effect to the Scheme of Amalgamation (hereinafter referred to as "the Scheme") between M/s. Simbhaoli Sugars Limited (hereinafter referred to as "Amalgamating Company" or "Simbhaoli Sugars") and M/s. Simbhaoli Spirits Limited (hereinafter referred to as "Amalgamated Company" or "Simbhaoli Spirits"), as sanctioned by the Hon'ble High Court of Judicature at Allahabad and in terms of Clause 16 of the Listing Agreement, the Company has fixed Thursday, 26th day of November, 2015 as the Record Date for the purpose of share exchange as per the Scheme of Amalgamation.

- (b) **"139 (One Hundred and Thirty Nine) fully paid-up Equity Shares of INR 10 (Rupees Ten) at a premium of INR 62 (Rupees Sixty Two) each of Amalgamated Company shall be issued"**
- (c) **and allotted for every 100 (One Hundred) fully paid-up Cumulative Redeemable Preference Shares of 100 (One Hundred) each held in Amalgamating Company"**

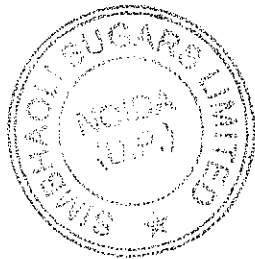
